What treatments is it available for?

- Psychology
- Psychotherapy

Through which types of appointment?

- Over the phone or video with our Talking Therapies team
- In person at a Mindplace, our mental health centres

How it works

Using Members First is easy with the My Bupa app. Here are the simple steps for your clients.

- 1. Log in to the app** and book a digital appointment with a GP or mental health specialist.
- If it's the right treatment for your client, **they'll be referred** for talking therapy.
- They don't need to contact us separately to pre-authorise their care. **We'll send them a pre-authorisation code** in the app and by email.
- 4. They can then book** their talking therapy session with a Bupa service, over the phone, video or in person.

How does it help your clients?

They won't pay extra costs

That means no excess or co-payment to pay and no impact on their outpatient allowance, no claims discount or low claims bonus, if they have one.

They'll get fast access

We'll aim to get them started with talking therapies in just 10 days.†

Your clients can book and manage their care with the My Bupa app. All they need to do is log in to use Blua, digital health by Bupa. If they'd prefer, they can sign in on the web.
